The Seller and Buyer agree to the following conditions of this agreement:

- (1) This cat is **not to be declawed** without written permission of the seller.
- (2) Adequate *indoor* sanitary facilities must be provided. **This cat WILL NOT roam outdoors.**
- (3) This cat is purchased as a: _____ Altered Pet _____ Show Quality Alter
- (4) Deposit _____, Purchase Price _____, Balance in cash _____
- (5) Deposit may be paid by check made out to **CYNTHIA SWALVE DEWOLFE** Deposit is non-refundable and is meant to hold a kitten/cat for you.
- (6) Seller will provide the following health guarantee:
 - (a) This cat is guaranteed for 48 hours against upper respiratory infection, fleas, worms or fungus and ear mites
 - (b) Seller guarantees that this cat does not have FeLV, FIP, or FIV at the time of pick up or delivery.
 - (c) If within 2 years of DOB, this cat is found to have a fatal hereditary or congenital defect, HCM or FIP, seller will replace cat with another cat/kitten of equal value, when seller receives proof of defect in the form of a complete autopsy report from a board certified specialist.. Buyer is responsible for any medical costs after purchase.
- (5) Buyer is advised to take this cat (at buyer's expense) to a veterinarian for a complete medical exam within 48 hours or 2 working days. The cat may be returned if any medical problem is found. This may be waived by both parties.

CAT / KITTEN RETURN POLICY:

If for any reason I have questions or concerns about said cat / kitten I will contact my breeder first and get input on my problem or concern, **BEFORE TAKING IT TO A VET.** If I need to place the kitten/cat for any reason, I will return said kitten to the Seller. I will never place this cat/kitten in a shelter, pet shop or allow it to be used for any animal testing. I agree that said kitten is to be returned to the Seller, should any thing happen where I can not take care of the cat/kitten any longer.

I have read and agreed to the contract, vaccine and feeding instructions and will abide by them.

Vaccination Suggestions

FEK-O-VAX PCT (killed virus only) used to prevent Panleukopenia, Rhinotracheitis and Calicivirus.

Shot record will be provided for adult cats. **MICROCHIP #** _____

NO FIP VACCINE: Please do not allow anyone to give this cat a vaccine for Feline Infectious Peritonitis. According to recent reports, this vaccine is totally ineffective and may actually predispose your cat to the disease.

NO FELINE LEUKEMIA VACCINATIONS: It is felt at this time that the risk of contracting this disease is far less than the severe reaction and even death that are occurring now by the vaccinations. Hopefully, better and safer vaccines will be available in the future. Until then, **just say NO! Give killed or modified live vaccines ONLY!**

RABIES VACCINATIONS: It is my feeling that indoor cats do not need Rabies shots. However, in some communities it is the law that cats must have the shot. The younger the cat is, the harder the Rabies shot is on a cat. When your cat has this or any other shot, watch the cat closely for a few hours. If your cat starts to vomit, drool, or has runny eyes, rush your cat back to the vet. These are signs of allergic reactions to the shot. If not treated immediately, the cat could die. This contract is **void should live vaccines** be used.

FEEDING SUGGESTIONS:

WATER: Water must be fresh and available at all times.

DRY FOOD: We feed Nutro Choice Complete Kitten and Iams Adult Hairball food. Adults are fed Nutro Gourmet Roasted Chicken & Hairball Formulas. You may mix or serve in separate bowls to be available 24 hours a day. Change to a premium adult food at one year old. We suggest Nutro. Please use a premium brand food, not grocery store brands. In the long run, premium food is no more expensive and your cat will eat less, and have less smelly stools and be a healthier cat for it.

WET FOOD: We feed wet food minimally. Using only a few teaspoons full at a time, twice per day. Cut back on it as your kitten eats more dry food, and give just as a treat.

DO NOT USE MILK. It can cause intestinal upset and make your kitten very ill.

STRING OF THREAD IS VERY DANGEROUS TO YOU CAT / KITTEN. Cats have small barbs on the back of their tongue that forces them to swallow the string once it is in their mouth, and they can not spit it out.

KEEP IT PUT AWAY!

MANY HOUSEHOLD PLANTS ARE TOXIC. BE AWARE OF WHICH ONES!
